To Our Friends,

As we prepare for a new millennium it only seems proper to reflect on our past and look forward to our future. My dad founded Prudential Overall Supply April 11, 1932. I would like to thank all our past and present employees for their contributions which have made POS a success. Many of these "old timers" I never knew but they built Prudential's foundation. I'm sure my dad never dreamed we would be as large as we are today; nineteen plants, annual revenue and sales pushing \$120,000,000 and almost 2,000 employees.

Most of us can not relate to 1932 because we were born after this date and our life experiences are closer to today than 1932. In 1932: (1) There was no federal minimum wage and the average worker was paid about \$.20 per hour. (2) Life expectancy was at least 15 years shorter than it is today. (3) The airline industry was just in its infancy. Airplanes could carry about 10 passengers; a very small percentage of people traveled by air. Today, a high percentage of people travel by air and the airplane has made the world a much smaller place. We can fly from L.A. to New York in the same time it took to drive from L.A. to Lake Arrowhead in 1932. (4) The U.S. population was about 122 million compared to 275 million today. (5) A medium priced house cost about \$3,000. (6) In 1932 the average household had less than one car. Today we average close to three cars per household and have much more mobility.

Remember, in 1932 there were *no* T.V.'s, cellphones, fax's, computers, refrigerators, ATM's, microwaves, organ transplants, laser surgery, knee replacements, penicillin, McDonalds, Starbucks, zippers, credit cards, freeways, or Disneyland.

Our industry hasn't really changed that much. We pick-up dirty and deliver clean merchandise to our customers and process this merchandise (wash, press, repair, fold) at our plants. New fabrics, new equipment, and new technology all do the same thing, just better and more efficiently.

Where do I see POS going in the next millennium? As long as we are true to our mission statement, POS will continue to grow and prosper. Sure, there will be more changes in fabric, equipment and technology and some changes we can not even envision today, but we can and will adapt. It's quite possible that by the year 2050 POS will have forty plants.

Prudential will continue to grow and be successful as long as we treat our employees as our most important asset and continuously improve our customer service.

At this time of year we cherish the privilege of expressing our sincere thanks to each of our customers, employees, suppliers and friends for the nice things they have done for us in 1999 and to extend our heart felt best wishes for the year 2000. It is my wish that we keep the holiday spirit alive throughout the year. This attitude of optimism, hope, faith, love and goodwill toward all will help to produce positive attitudes and results in each one of us.

May God grant each of you joy, peace and happiness in this Holiday Season and the forthcoming year.

Richmond Cleanroom Opens!

Prudential's newest Class 1 cleanroom opened on June 29, 1999.

Located in Richmond, Virginia, the \$4 million Cleanroom Plant contains 30,000 square feet. The Richmond Cleanroom is Prudential's first location east of the Mississippi. Prudential is recognized as having the best Cleanroom facilities in the world.

The decision to locate in Richmond was based on its geographic location. "We see tremendous opportunity for growing cleanroom garment and consumable product business in this region," said Terry Lahn, Vice President, Cleanroom Operations.

"This is a growth year for us. We are really concentrating on revenue and sales," said Richmond General Manager Barry Easdale.

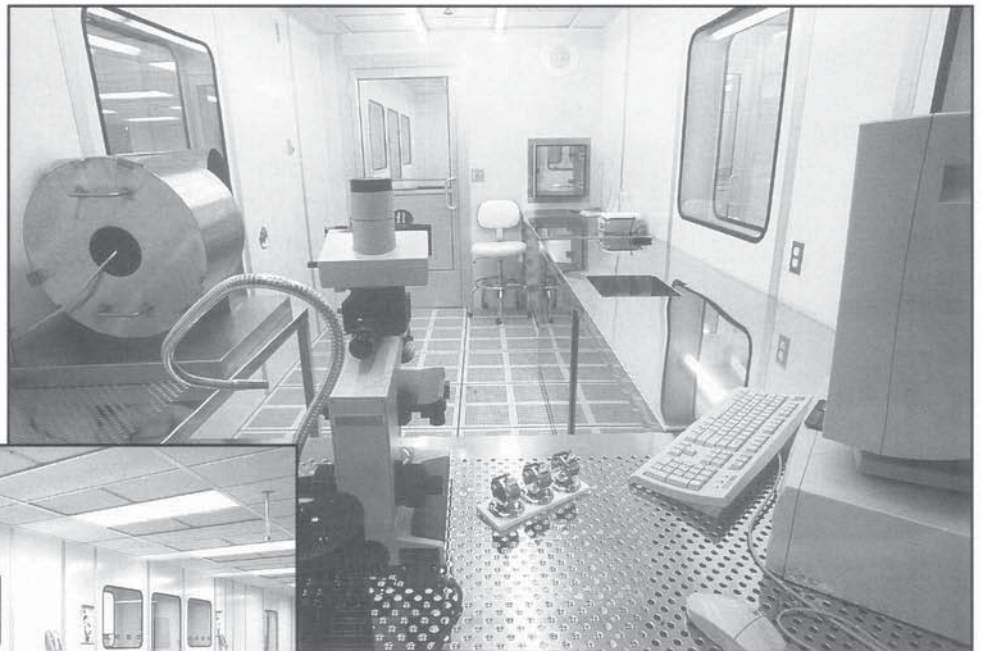
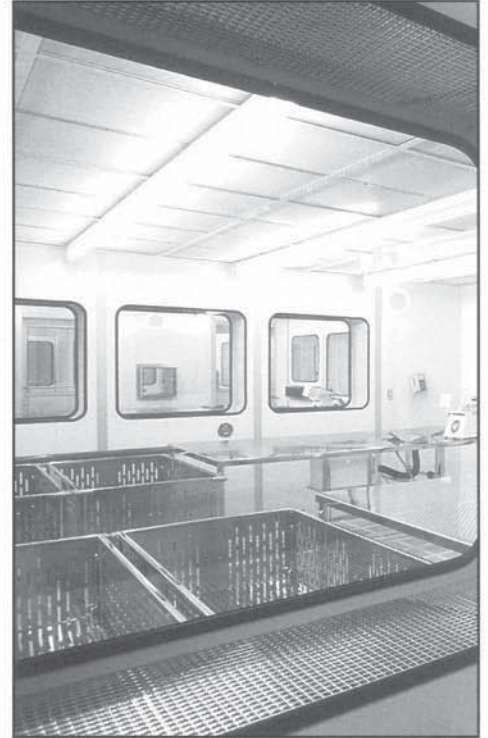
The success of the new cleanroom depends in large part on the talent of its employees. "We've been very fortunate in finding great people," said Barry. "We couldn't ask for a better staff."

The Richmond Cleanroom's first customer over two years ago was White Oak Semiconductor.

White Oak Semiconductor is headquartered on 210 acres in the White Oak Technology Park near Richmond. The company employs 1,500 people and currently produces 64M and 256M DRAM devices. The 825,000 square foot site is fully integrated with wafer manufacturing, probe, assembly, final test, and module assembly.

"We have been very happy with Prudential," said White Oak Contamination Control Specialist, Hunt Knight. "We feel kind of special. They built a Cleanroom laundry for us. We feel like we've formed a good partnership with a great company," he said.

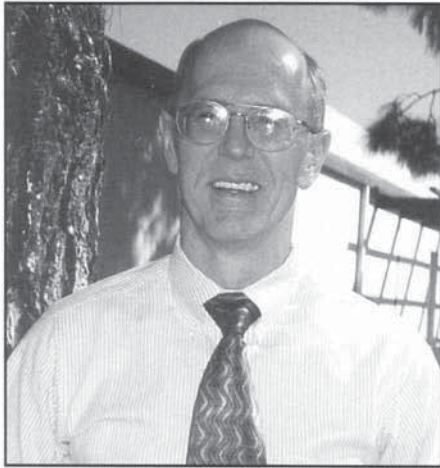


The White Oak Semiconductor headquarters near Richmond.

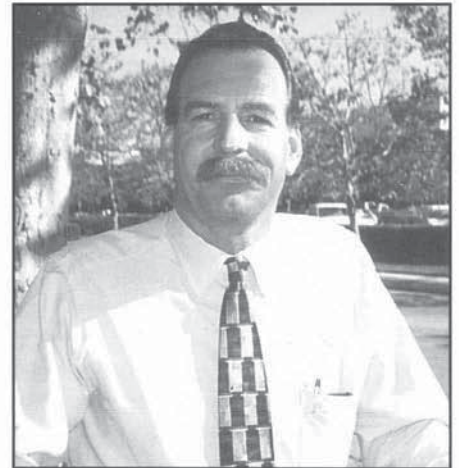
Bill Stoner

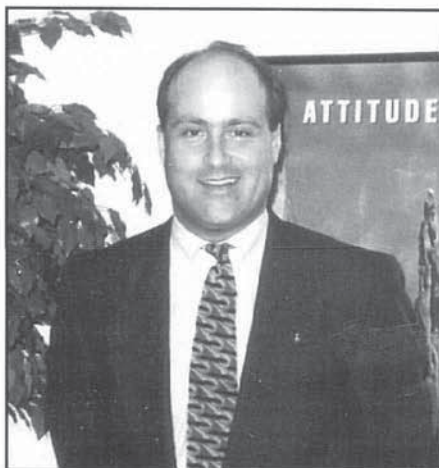
Frank Rich

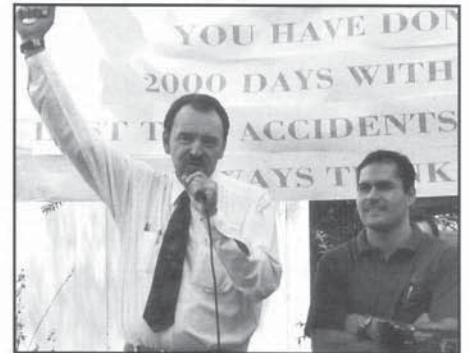
